If this happens, I will be contacted and my child will be sent home immediately **at my expense**.

I also understand that the Praise Church leadership staff and the Bilbos are not responsible for any lost or stolen items. My child will not bring non-essential expensive items.

I give my permission for me/my child/children to ride in the provided transportation that the Praise Church leaders have arranged and will not hold Praise Church, the Bilbos and other designated drivers personally responsible for any accidents. I understand that my child may ride on a motor coach, a van rented by the church, or with the Bilbos, or other drivers designated by the Praise Church leadership staff.

Those riding in their own arranged transportation understand and agree that they are part of the conference group and will participate in all group activities. Rule 11 reads: Regardless of age, no youth will be allowed to leave the conference group and "do their own thing" for any reason without prior permission from the Praise Church leadership staff or the Bilbos. No youth will be allowed to leave on their own, unsupervised and roam around alone.
